The FAC discussed that our current sweep account is to Fidelity Treasury MM, there is a zero-balance left in the checking account, meaning each night, only the funds needed to pay pending transactions are left in the checking account. As per the vote at the March 16, 2023, meeting, Ms. Schaefer will open an account at a larger national bank, to be determined by the development department as our best strategic partnership choice, so that we have an established second checking account should an emergency situation arise.

BOARD DESIGNATIONS

The FAC reviewed the projected liquidity position for June 30, 2023 and determined that with \$2M in board designations our liquidity position would still be very favorable.

Motion to recommend that the State Board designate a total of \$2M dollars, with \$1M designated for capital projects and \$1M designated for Program Innovation was made by Ms. Quick.

Motion was seconded by Mr. Richins.

Motion passed.
